SECTION 4: FIRST AID MEASURES

SECTION 6: ACCIDENTAL RELEASE MEASURES

Personal Precautions, Protective Equipment and Emergency Procedures: Control the spill at its source. Clean up spills immediately, observing precautions outlines in Sections 7 and 8. Use adequate ventilation and equipment and wear clothing as described in Section 8 and/or the product label.
