4. FIRST AID MEASURES

6. ACCIDENTAL RELEASE MEASURES

Clean up spills immediately observing the precautions in Section 8 of this SDS. Isolate the hazard area and keep unnecessary and unprotected personnel from entering.

Spill cleanup: Prevent material from further release into soil, surface water and ground water. Absorb spill with inert material (such as dry sand, clay or earth), then place in an appropriate container for disposal. Wash area with soap and water. Pick up wash liquid with suitable absorbent material and place in container for disposal. Stop or reduce contamination of any water. Isolate contaminated water.

7. HANDLING AND STORAGE
