SECTION – 3: HAZARDS IDENTIFICATION

Symptoms of Acute Exposure

Harmful if inhaled. Causes mild eye and skin irritation.

Hazardous Decomposition Products

Can decompose at high temperatures forming toxic gases.

Physical Properties

Appearance: Reddish-brown granules.

Odour: Sweet aromatic.

Unusual Fire, Explosion and Reactivity Hazards

During a fire, irritating and possibly toxic gases may be generated by thermal decomposition or combustion.

Potential Health Effects

Relevant routes of exposure: Skin, eyes, mouth, lungs.

SECTION - 4: FIRST AID MEASURES

IF POISONING IS SUSPECTED, immediately contact the poison information centre, doctor or nearest hospital. EYE CONTACT: Immediately flush eyes with clean water, holding eyelids apart for a minimum of 20 minutes.

Remove contact lenses, if present, after 5 minutes, then continue rinsing eye. Call Syngenta, a poison control center or doctor for treatment advice. Obtain medical attention immediately if

irritation persists.

SKIN CONTACT: Immediately remove contaminated clothing and wash skin, hair and fingernails thoroughly with

soap and water. Flush skin with running water for a minimum of 20 minutes. Obtain medical

attention if irritation occurs.

INHALATION: Move victim to fresh air. If not breathing, call 911 or an ambulance, then give artificial

respiration, preferably mouth-to-mouth, if possible. Call Syngenta, a poison control centre or

doctor for treatment advice.

INGESTION: If swallowed, immediately contact Syngenta, a poison control centre, doctor or nearest hospital for

SECTION – 5: FIRE FIGHTING MEASURES

Flash point and method: 95 °C.

Upper and lower flammable (explosive) limits in air: Not Applicable.

Auto-ignition temperature: 260 °C. **Flammability:** Not flammable.

Hazardous combustion products: During a fire, irritating and possibly toxic gases may be generated by thermal

decomposition or combustion.

Conditions under which flammability could occur: None known.

Extinguishing media: Use foam, carbon dioxide, dry powder or halon extinguishant. Wear full protective clothing and self-contained breathing apparatus. Evacuate nonessential personnel from the area to prevent human exposure to fire, smoke, fumes or products of combustion. Prevent use of contaminated buildings, area, and equipment until decontaminated. Water runoff can cause environmental damage. Contain run-off water with, for example, temporary earth barriers.

SECTION - 6: ACCIDENTAL RELEASE MEASURES

Personal Precautions: Make sure all personnel involved in the spill cleanup follow good industrial hygiene practices. A small spill can be handled routinely. Use adequate ventilation and wear equipment and clothing as described in Section 8 and/or the product label.

Procedures for dealing with release or spill: Control the spill at its source. Contain the spill to prevent from spreading or contaminating soil or from entering sewage and drainage systems or any body of water. Clean up spills immediately, observing precautions outlined in Sections 7 and 8. Scoop or sweep up material and place into a disposal container. Wash area with detergent and water. Pick up wash liquid with additional absorbent and place into compatible disposal container. On soils, small amounts will naturally decompose. For large amounts, skim off the upper contaminated layer and collect for disposal. Once all material is cleaned up and placed in a disposal container, seal container and arrange for disposal. Spillages or uncontrolled discharges into watercourses must be reported to the appropriate regulatory authority.

SECTION - 7: HANDLING AND STORAGE

Handling practices: KEEP OUT OF REACH OF CHILDREN. Prevent eating, drinking, tobacco use, and cosmetic application in areas where there is a potential for exposure to the material. Avoid breathing vapours or spray mist. Wear full protective clothing and equipment (see Section 8). After work, rinse gloves and remove protective equipment, and wash hands thoroughly with soap and water after handling, and before eating, tobacco use, drinking, applying cosmetics or using the toilet. Wash contaminated clothing before re-use and separate from household laundry. Keep containers closed when not in use. Protect product, wash or rinse water, and contaminated materials from uncontrolled release into the environment, or from access by animals, birds or unauthorized people.

Appropriate storage practices/requirements: Store in original container only in a well-ventilated, cool, dry, secure area. Protect from heat, sparks and flame. Do not expose containers to temperatures above 40 °C. Keep separate from other products to prevent cross contamination. Rotate stock. Clean up spilled material immediately.

Applicable control measures, including engineering controls: This product is intended for use outdoors where engineering controls are not necessary. If necessary, ensure work areas have ventilation, containment, and procedures sufficient to maintain airborne levels below the TLV. Warehouses, production area, parking lots and waste holding facilities must have adequate containment to prevent environmental contamination. Provide separate shower and eating facilities.

General: Avoid breathing dust, vapours or aerosols. Avoid contact with eye, skin and clothing. Wash thoroughly after handling and before eating, drinking, applying cosmetics or handling tobacco.

INGESTION: Do not eat, drink, handle tobacco, or apply cosmetics in areas where there is a potential for exposure to

this material. Always wash thoroughly after handling.

Toxicity of Other Components

The acute toxicity test results reported in Section 11, above, for the finished product take into account any acute hazards related to the "other components" in the formulation.

Attapulgite Clay:

Listed as an IARC (Group 2B) carcinogen. Prolonged or repeated inhalation of dust may cause a disabling, progressive pulmonary fibrosis. Inhalation hazard may not exist in the liquid form. May cause eye irritation.

n-Methylpyrrolidone:

Contact with the liquid results in moderate eye irritation and may cause temporary corneal clouding. Skin contact results in mild irritation. Prolonged skin contact may result in redness and dermatitis. Inhalation of vapours may result in respiratory irritation. Teratogenic and reproductive effects were noted in animal studies at high dose levels.

Crystalline Silica, Quartz:

Chronic inhalation exposure to crystalline silica is known to cause silicosis and pulmonary fibrosis in humans. Experimental animals exposed to crystalline silica developed respiratory tract cancers.

Other materials that show synergistic toxic effects together with the product: None known.

Summary of Effects

RIDOMIL GOLD 1G is an in-furrow fungicide for the systemic control of disease in registered crops. The active ingredient, metalaxyl-M, is practically non-toxic to slightly toxic to fish, birds, aquatic invertebrates and insects (bees).

The active ingredient metalaxyl-M has a low bioaccumulation potential, a low to high mobility in soil (depending on soil type), and is not persistent in the environment. The main route of dissipation is by biological degradation.
