### 4. FIRST AID MEASURES

#### 4.1 Description of First Aid Measures

## 6. ACCIDENTAL RELEASE MEASURES

### 6.1 PERSONAL PRECAUTIONS, PROTECTIVE EQUIPMENT AND EMERGENCY PROCEDURES
