4. First-aid measures

6. Accidental release measures

Personal precautions, protective equipment and emergency procedures	Keep unnecessary personnel away. Keep people away from and upwind of spill/leak. Use a NIOSH/MSHA approved respirator if there is a risk of exposure to dust/fume at levels exceeding the exposure limits. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Ensure adequate ventilation. Methods and materials for containment and cleaning up	Stop the flow of material, if this is without risk. Avoid dispersal of dust in the air (i.e., clearing dust surfaces with compressed air). Absorb in vermiculite, dry sand or earth and place into containers. Large Spills: Wet down with water and dike for later disposal. Collect dust using a vacuum cleaner equipped with HEPA filter. Avoid the generation of dusts during clean-up. Shovel the material into waste container. Following product recovery, flush area with water. Small Spills: Wipe up with absorbent material (e.g. cloth, fleece). Clean surface thoroughly to remove residual contamination. For waste disposal, see section 13 of the SDS. Never return spills to original containers for re-use.
Environmental precautions	Avoid discharge into drains, water courses or onto the ground.

Precautions for safe handling	Provide appropriate exhaust ventilation at places where dust is formed. Minimize dust generation and accumulation. Avoid breathing dust. Avoid contact with eyes. Wear appropriate personal protective equipment. Observe good industrial hygiene practices. Avoid prolonged exposure.
