4. FIRST AID MEASURES

4.1 Description of First Aid Measures

General Advice: Get medical attention if symptoms occur.

- Eye contact:** Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.

5. FIRE FIGHTING MEASURES

- 5.1 EXTINGUISHING MEDIA:**
Suitable Extinguishing Media: Use medium appropriate to surrounding fire. Dry chemical, carbon dioxide (CO₂), foam, water spray or fog. Do not use water jet as this will spread the fire.

Environmental Precautions: Prevent further leakage or spillage if safe to do so. Do not contaminate water. Do not allow to enter drains, sewers, or watercourses.
- 6.3 METHODS AND MATERIALS FOR CONTAINMENT AND CLEAN-UP**
Methods for Clean-Up: Large Spills: Stop the flow of material, if this is without risk. Dike the spilled material, where this is possible. Absorb in vermiculite, dry sand or earth and place into containers. After removal flush contaminated area thoroughly with water.
Small Spills: Wipe up with absorbent material (e.g. cloth, fleece). Clean surface thoroughly to Remove residual contamination.
Never return spills to original containers for re-use.

7. HANDLING AND STORAGE

- 7.1 PRECAUTIONS FOR SAFE HANDLING:**
Advice on Safe Handling: Avoid inhalation of dusts, vapors / spray and contact with eyes, skin and clothing. Do not breathe dusts, mist or vapor. Wear personal protective equipment. Do not use in areas without adequate ventilation. Avoid prolonged exposure. Wash thoroughly after handling. Do not empty into drains. Handle and open container with care. Engineering Measures
