DIRECTIONS FOR USE: 42PHI Zn/Mn should be used based on soil and tissue analyses in accordance with the recommendation of a qualified person or institution such as a certified crop consultant, agronomist, university crop extension publication or apply according to recommendations in your approved nutrient plan.

General application rate is 1 quart/acre.

COMPATIBILITY: Tank mix compatibility is impacted by water quality which may vary by location. DO NOT MIX 42PHI Zn/Mn in a concentrated form with other fertilizers or pesticides. When mixing, always ensure adequate dilution in the spray tank before adding 42PHI Zn/Mn. A standard iar test is recommended prior to mixing with other fertilizers or pesticides.

If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, mouth-to-mouth, if possible. Call a poison control center or doctor for further treatment advice.
