FIRST AID

AdjuTec® ZEPHYR II is a NPE free deposition and drift management agent that improves the uniformity and density of spray droplets to maximize pesticide performance.

MIXING INSTRUCTIONS

Add AdjuTec ZEPHYR II to the spray tank after all other tank mix partners have been added to the tank. Avoid mixing with other undiluted products in an induction cone or any other container.

USE RATE:

Ground: 3-4 oz/A
Aerial: 2-3 oz/A

STORAGE AND DISPOSAL
