GENERAL: Afterburner is a unique low salt NPK formulation with Magnesium reacted with biostimulants in order to facilitate fast seed germination and early season growth.

DIRECTIONS FOR USE: **CAUTION:** This fertilizer contains Magnesium and should only be used as recommended. It may prove harmful if not used correctly. Seek advice of a certified crop consultant for application rates and timings for desired crops.

Foliar Applications: Apply 1.2L – 2.4L per Hectar (500ml – 1Lper acre) in a minimum of 10Ga water per acre. Do not exceed 4.8 L /Ha (2L/Acr) per growing season. Application can be made at herbicide application timing. This product can be tank mixed, always conduct a jar test first to ensure compatibility before putting in tank.

FIRST AID: If on skin: Remove contaminated clothing. Wash skin thoroughly with soap and water. Wash clothing before reuse. If in eyes: Flush with running water for at least 15 minutes while holding eyelids open. Get medical attention. Ingestion: Drink 1-2 glasses of water and induce vomiting.
