AlliCURB™ MAX is a unique garlic oil-based formulation designed to deliver highly effective garlic oil components that control and repel a broad range of pests, such as mites, Lepidoptera and other soft-bodied insects on all crops. AlliCURB MAX acts as an odor-masking compound to confuse pests during mate pairing, deters egg laying on treated crops, and is a feeding deterrent for insect pests. In addition, AlliCURB MAX is a contact insecticide and does not leave a garlic taste on food crops.

# DIRECTIONS FOR USE

READ THE ENTIRE LABEL - USE IN ACCORDANCE WITH LABEL INSTRUCTIONS

**USE SITES:** For use on all agricultural crops, including food crops. Indoor and outdoor fields and rows including but not limited to all fruits and vegetables, orchards, fruit trees, nut crops, grapes, hops, greenhouses, nurseries, ornamentals and landscapes.

**THIS PRODUCT IS A CONCENTRATE AND MUST BE DILUTED BEFORE USE.**

## MIXING INSTRUCTIONS - SHAKE WELL BEFORE USING -

**Use dilution immediately - Do not store diluted solution.**

The use of an adjuvant is not required with AlliCURB MAX. Fill a clean tank with half the amount of required clean water. With the agitator running, add the desired amount of AlliCURB MAX to the mix tank, following the application rate table. Continue agitation while filling the tank with the remaining required amount of water. Thoroughly mix until a homogeneous mixture is obtained. After AlliCURB MAX has completely dispersed into the mixed water, start applying the solution. For best results, maintain constant agitation in spray equipment.

**COMPATIBILITY OF SPRAY MIXTURES** - Limited compatibility testing has been conducted for AlliCURB MAX with other commonly used chemistries. As such, tank mixing or use of AlliCURB MAX with any other products shall be the exclusive risk and responsibility of the user. Do not tank mix this product with oxidizing agents such as bleach, or highly alkaline or acidic products. Consult specific product labels for additional information. Conduct a tank mix compatibility test when you mix AlliCURB MAX with other products and test the mixture on a small scale before making large-scale applications. pH: It is advisable to maintain the final spray mixture at a neutral to slightly acidic pH (pH 6-7.5).

**PLANT SAFETY- PHYTOTOXICITY** - Since plant varieties are numerous and may react differently to AlliCURB MAX, test the product on a small scale before making large-scale applications. Do not apply on plants under stress or when the temperature is 90 °F or above.

**APPLICATIONS** - Apply the diluted solution using clean standard sprayers, backpacks, or other hand-held spray equipment to achieve uniform and complete spray coverage on the crop and all leaf surfaces until runoff.

**TIMING** - Begin spraying when pest pressure is expected or when pests first appear. Do not wait until plants are heavily infested. Apply in the early morning or late afternoon. AlliCURB MAX has a 0-day preharvest interval (PHI); it may be applied to crops at any time, including the day of harvest. Repeat as needed to maintain the desired level of control (5-day minimum interval). AlliCURB MAX has a 0-hour restricted entry interval (REI).

### STORAGE AND DISPOSAL

**STORAGE:** Do not contaminate water or food by storage and disposal. Store in original container in a cool, well-ventilated, dry place (68-80 °F). Do not freeze. Keep container closed when not in use. **CONTAINER DISPOSAL:** Nonrefillable container. Do not reuse or refill this container. **IF EMPTY:** Offer for recycling if available or reconditioning if appropriate or puncture and dispose of in a sanitary landfill or by incineration. **IF PARTLY FILLED:** Call your local waste agency for disposal instructions.
