## GENERAL INFORMATION

H2O Conditioner contains a deposition agent, formulated to enhance spray coverage and retention of pesticide products, that recommend the use of ammonium sulfate or a nitrogen source.

H2O Conditioner improves efficacy of various pesticide sprays by minimizing antagonism caused by hard water metal ions that are generally present in most spray water sources.

The humectant ingredient in H2O Conditioner slows the drying time of spray droplets and minimizes crystal formation of pesticide residues that can impede plant uptake.

The acidifying agents in H2O Conditioner modify spray water pH.

The antifoam ingredient in H2O Conditioner minimizes formation of troublesome foam.

## DIRECTIONS FOR USE

For use with products registered for agricultural, forestry, industrial, municipal, non-cropland, ornamental, rights-of-way and other uses. This product cannot be used for aquatic applications.

Always read and follow label directions of the pesticide before using H2O Conditioner. Unless otherwise instructed by pesticide label recommendations, always add H2O Conditioner first to the tank mix prior to other tank mix partners.

## USE RATE

**Ground:** Apply at a rate of 2 to 4 quarts in 100 gallons of spray mix (0.5% to 1.0% v/v)

**Aerial:** Use 1 to 2 quarts per 100 gallons (0.25% to 0.5% v/v)
