A small percentage (3-5%) of the meat and bone meal is used as a binder.

**BENVIREO StimSentials 5-4-1** can be used as a fall or spring application to stimulate microbial populations. It is most efficient when incorporated into the soil. Consult your Wilbur-Ellis representative for specific use rates.
