GENERAL INFORMATION

BenVireo Stimtide 5-0-0 is designed to prevent or correct nitrogen deficiencies in a wide range of agronomic plants. It should be used as part of a comprehensive Total Nutrition System® for sustaining plant growth, development, yield and quality.

DIRECTIONS FOR USE

BenVireo Stimtide 5-0-0 can be used on field and specialty crops. Rates of application and timing of treatment should be based on crop nutrient demand, prevailing environmental conditions, plant tissue analysis data, or other information that indicates a need for supplemental nitrogen. Consult your Wilbur Ellis representative for rates specific to your crops and conditions.

FOLIAR APPLICATIONS: Apply 1-2 pints per acre by air, ground or sprinkler. Dilution in water is required. Maintain proper agitation to provide uniform distribution within the spray tank. Thorough and even spray coverage is essential for maximum nutrient uptake and crop safety. Always include a high-quality wetting agent, such as SYL-COAT®, at recommended rates. Do not apply when plants are under excessive heat stress or moisture stress. Applications may be repeated up to 6 times per growing season.

COMPATIBILITY: BenVireo Stimtide 5-0-0 is compatible with many co-applied nutrient sources as well as plant protection products. Always jar test new combinations for compatibility prior to field mixing.
