Blossom SS is a highly effective calcium formulation designed to cover and penetrate plant tissue. Specific rate recommendations should be made based on the crops calcium and boron demand or tissue analysis. This proprietary formulation is to be used on Vegetables, Fruit trees, and Berry Crops. Seek the advice of a certified crop consultant for application rates and timings for desired crops

FOLIAR APPLICATIONS: Apply 2-5L / Ha in 450L water / Ha (Apply .5 - 2 Qrt/Acr in a minimum of 52 Ga of water per Acre). Repeat applications as needed. Recommended application timing is during flowering stages only. Blossom SS should be well mixed with water before application. Conduct a jar test for tank mixing with other products. Repeat every 14 days for a maximum of 4 applications per season.

FIRST AID: If on skin: Remove contaminated clothing. Wash skin thoroughly with soap and water. Wash clothing before reuse.
