Cavalry™ Envoy is an NPE-free surfactant, humectant and ammonium sulfate based water condition agent that improves the ability of the spray droplet to enter the plant and maximize pesticide performance.

### MIXING INSTRUCTIONS

Add Cavalry Envoy to the spray tank after all other tank mix partners have been added to the tank. Avoid mixing with other undiluted products in an induction cone or any other container.

### Use Rate

Glufosinate Herbicides: 3.5 pt/A  
Glyphosate Products alone, premixed or tank mixed: 1-2.5% v/v or as directed by herbicide label.  
If applying with herbicides that require approval for tank mix partners, consult the appropriate website for the herbicides involved to assure that Cavalry Envoy is approved for use.
