**GENERAL INFORMATION**

**Constrain XLT Plus** reduces the impact of environmental stressors, such as excess light, heat, drought, cold and other environmental or induced conditions that negatively impact crop productivity. **Constrain XLT Plus** contains a blend of plant metabolites and crop enhancement components, which controls enzymes associated with stress responses. **Constrain XLT Plus** can be applied throughout the cropping season.

**DIRECTIONS FOR USE**

**Application Information**

Foliar applications should be made in sufficient water volume to provide adequate uniform coverage and wet foliage. If spraying **Constrain XLT Plus** alone, use Aurora ETA at 8 ounces/A. If tank mixing **Constrain XLT Plus**, follow the tank mix product(s) recommendations for specific adjuvant uses. **Constrain XLT Plus** can be tank mixed with herbicides, insecticides, fungicides and fertilizers. **Constrain XLT Plus** may be applied by ground or aerial equipment to all crops.

**Mixing Instructions**

1. Fill spray tank one-third to one-half full, maintaining agitation.
2. Add adjuvants and other tank mix materials to the spray tank.
3. Add appropriate amount of **Constrain XLT Plus**.

**Tank Mix Instructions**

Since all combinations have not been tested, the compatibility of **Constrain XLT Plus** with any potential tank mix partners should be determined in small amounts with a jar test.

**Use Rate**

Use Rate for all crops is **8 ounces/A**, per application.  
Multiple applications can be made.

**APPLICATION & TIMING SUGGESTIONS**

**Constrain XLT Plus** may be applied at any time during the cropping season. This includes all crops – there are not any specific crop labeling restrictions.

There are not any preharvest restriction intervals (PHI's).

**Suggested applications include:**

- In-Furrow (with starter fertilizer applications)
- Pre-Plant (included with pre-emerge herbicide/fertilizer applications)
- Early - Postemergence (with planned post-applied pesticides, nutritionals)
- Late - Postemergence (with planned post-applied pesticides, nutritionals)
