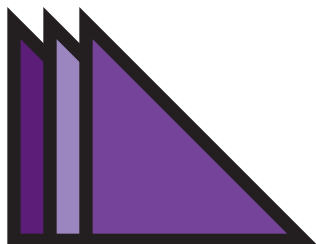

Do not allow water or other chemicals to be introduced into contents of container. Do not contaminate water sources with equipment wash water, spray disposal wastes or by cleaning of equipment. Do not store near feed or food products.

GENERAL INFORMATION

CORNBELT® OPTILOX™ is a high load surfactant containing a multifunctional patented nonionic surfactant (NIS) and drift & deposition management agent with anti-bounce technology. Use CORNBELT® OPTILOX™ when the pesticide label calls for either a crop oil concentrate (COC) or an NIS and you want better canopy penetration and droplet retention on the leaf surface. The adhesive properties of CORNBELT® OPTILOX™ provide superior anti-bounce of the spray droplet and greater retention on the leaf surface. The citric acid in CORNBELT® OPTILOX™ functions as a chelating agent which chelates hard water cations such as calcium, iron, manganese, and magnesium, preventing them from binding to the herbicide and adversely affecting the performance of the herbicide. CORNBELT® OPTILOX™ is APE and NPE free and may be used anytime the pesticide label calls for the use of either a COC or an NIS.

DIRECTIONS FOR USE

CORNBELT® OPTILOX™ is intended for use with products registered for agricultural, horticultural, turf, ornamental, industrial, and non-crop uses.

WARNING: Read and follow all pesticide label directions. Do not use where the pesticide label specifically prohibits the use of an adjuvant. If the pesticide label neither recommends nor prohibits an adjuvant, the applicator must have previous experience with the adjuvant/pesticide spray mixture or should apply a small test area before making large scale applications. The addition of an adjuvant to spray mixtures may cause phytotoxicity to susceptible crop and vegetation. Care should be exercised when using on new varieties of crops not previously treated with CORNBELT® OPTILOX™.

USE RATE (GROUND APPLICATION): Add CORNBELT® OPTILOX™ at 1 to 2 quart per 100 gallon of water. Use the higher rate when applying to larger, difficult to control weeds in adverse spray conditions. Alternatively, CORNBELT® OPTILOX™ may be applied on a rate per acre basis based on the amount of spray volume applied per acre.

USE RATE (AERIAL / DRONE APPLICATION): Add CORNBELT® OPTILOX™ at 2 to 4 ounces per acre to the tank mix with approved fungicide, herbicide, and/or insecticide.

MIXING: If atrazine is to be included in the spray mix, add atrazine as the first component of the spray tank mixture, then add CORNBELT® OPTILOX™. Otherwise, add CORNBELT® OPTILOX™ as the first component of the spray tank mixture.
