**GENERAL INFORMATION:** Delta Complete™ is volatility reduction adjuvant (VRA)/humectant/drift potential when tank mixed with dicamba. Delta Complete will reduce, but not eliminate drift. The degree of drift hazard varies with type of pesticide, application conditions, and the vegetation near the sprayed area. Common sense and sound application technology must be followed when spraying pesticides. Delta Complete contains a molybdenum inclusion to enhance the utilization of Nitrogen.

#### **DIRECTIONS FOR USE:**

Add 1.75 gallons of Delta Complete per 100 gallons of spray solution (1.75% v/v) when used as volatility reduction adjuvant (VRA). For general use as a drift reduction agent (DRA) use 1.75 gallons of Delta Complete per 100 gallons of spray solution (1.75% v/v).

#### **MIXING**

All spray mixing application equipment must be thoroughly cleaned before pesticides are applied.

1. Fill spray tank half full of water start agitation.
2. Add desired rate of Delta Complete to water before adding pesticides.
3. Add pesticides as directed by the label, while maintaining agitation.

#### **STORAGE AND DISPOSAL**

**STORAGE:** Suggested storage above 40°F. If frozen, warm product before use. Store in cool, dry place. Store in original container. Keep tightly closed.
