GENERAL INFORMATION

Dialed-In will reduce the amount of spray droplets that have a high potential to move off target in ground applications when applied through nozzles that are classified to produce extremely course and ultra course droplet spectrums. Dialed-In should be used in conjunction with proper spray equipment selection, set-up, and use including boom height, nozzle type, size and pressure. Along with good judgment and the proper selection and use of spray equipment, Dialed-In can help reduce off target drift.

DIRECTIONS FOR USE

Dialed-In may be used in ground applications through nozzles that deliver a droplet spectrum that is categorized as extremely and ultra-coarse.

Rate of application: Dialed-In may be used at a rate of 0.5% v/v.

Mixing Instructions: Add Dialed-In after wettable powders, dry flowables, liquid flowables, and suspensions but before emulsifiable concentrates and other adjuvants. Agitate after adding Dialed-In for five minutes before beginning spray application. Follow specific tank mix filling and mixing information provided on partner product labels. Follow the most restrictive label.

Before mixing, conduct a jar test to determine compatibility.

DO NOT use Dialed-In through a direct injection system.

STORAGE AND DISPOSAL

Recyclable Container Disposal: Do not reuse this container for any purpose. This is a recyclable container, and is to be disposed of at a container collection site. Contact your local distributor/dealer or municipality for the location of the nearest collection site. Before taking the container to the collection site:

1. Triple- or pressure-rinse the empty container. Add the rinsings to the spray mixture in the tank.
2. Make the empty, rinsed container unsuitable for further use.
