DIRECTIONS FOR USE:

INJECTION APPLICATION RATES:

For highbush blueberries, raspberries, cranberries, and stone fruits:

Use 30-45L/Ha (4-5Ga/Acre) as needed.

For Vegetables including Cucurbits, Brassica, Peppers, Tomatoes,

and row crops: Use 15-30L per Ha (1.6-3.3Ga per acre)

MIXING INSTRUCTIONS:

This blend mixes easily with water. For commercial injection systems only.

Can be injected as a concentrate with water or can be diluted with water prior to injection.

FIRST AID MEASURES: If on skin: Remove contaminated clothing. Wash skin thoroughly with soap and water. Wash clothing before reuse.
