GENERAL INFORMATION

Product Benefits: Canopy penetrating agent, penetrant, evaporation reduction agent, foliar retention agent, and nonionic surfactant.

IN-Plant ADV is a unique hybrid activator adjuvant that combines the functions of a nonionic surfactant, oil concentrate and penetrant in a single product. It may be used as a replacement for crop oil concentrates and high surfactant oil concentrates. IN-Plant ADV may also be used where the spray mixture benefits from a nonionic surfactant. IN-Plant ADV contains agents that can also improve spray deposition and rainfastness while increasing uptake of active ingredients.

DIRECTIONS FOR USE

Prior to use, read all directions on this label and on the label of the pesticide to be applied.

Do not use where the pesticide label prohibits the use of an adjuvant. If the label neither recommends nor prohibits an adjuvant, the applicator must have prior experience with the adjuvant/pesticide mix under local conditions.

The addition of adjuvants to some pesticides, fertilizers and their tank mixes may cause phytotoxicity. Before using *IM-Plant ADV*, the applicator or crop advisor must have experience with the pesticide combination, including *IM-Plant ADV* or must have conducted a phytotoxicity test.

USE RATES

Ground: As an oil concentrate replacement

With herbicides: 1-4 pints per 100 gallons of spray (0.125 - 0.50% v/v).

A general use rate of 2–3 pints per 100 gallons of water will fit most herbicide applications. Higher rates may be beneficial where weeds are larger or hard to kill, or when the crop canopy is dense.

With insecticides, fungicides, biostimulants, PGR's: 0.5–1 pint per 100 gallons of spray.

Air: 4–8 ounces per acre. Refer to pesticide label for minimum water volume per acre.

These rates are sufficient for most uses. Some pesticide labels may require higher or lower adjuvant rates. Read and follow the pesticide label in such cases.

MIVING

Always start with spray equipment that has been thoroughly cleaned. Refer to the specific mixing instructions listed on the respective pesticide label(s) prior to mixing. In the absence of specific mixing instructions, fill the spray tank with at least 50% of the final carrier volume. While the carrier is agitating, add tank mix incredients in the following order:

- 1. Antifoam and / or compatibility agent
- 2. Dry formulations (WP, DF, WDG, SG, SP) and ammonium sulfate
- 3. Flowable formulations (F & FL), liquid concentrates or suspensions (LC, ME, SC, CS)
- 4. Emulsifiable concentrates (E or EC)
- 5. Soluble liquids (S or SL)
- 6. IN-Plant ADV, water conditioners and other adjuvants
- 7. Finish filling and continue agitation

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

STORAGE: Store in a cool, dry place, in original container only. Keep containers tightly sealed when not in use.

PRODUCT DISPOSAL Wastes resulting from the use of this product must be disposed of on site or at an approved waste disposal facility.

CONTAINER DISPOSAL: Do not reuse empty container. Triple rinse (or equivalent) during mixing and loading. Recycling decontaminated containers is the best option of container disposal if allowed by law.
