

Non-AMS Water Conditioner, Surfactant, Drift Retardant

GENERAL INFORMATION

Condense+DRA is a water-conditioning agent/surfactant/drift reduction agent with defoamer, that is formulated to enhance pesticidal performance. Condense+DRA contains buffering and chelating agents which aid in maintaining the right pH in the tank mix solution and block hard water cations from interacting with the pesticide molecule. Condense+DRA contains nonionic surfactant to improve retention and wetting of pesticides. Condense+DRA contains no ammonium sulfate (AMS).

HANDLING AND STORAGE

Harmful if inhaled or absorbed through skin. Avoid contact with skin, eyes, or clothing. Avoid breathing spray mist. Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum or smoking tobacco. Remove and wash contaminated clothing before reuse. Personal Protective Equipment: Wear chemical-resistant gloves, long-sleeved shirt and long pant, and shoes plus socks.

DIRECTIONS FOR USE

Mixing: All spray mixing and application equipment must be thoroughly cleaned before pesticides are applied.

- 1. Fill spray tank half full of water and start agitation.
- 2. Add desired rate of Condense+DRA to water before adding pesticides.
- 3. Add pesticides as directed by the label, while maintaining agitation.

FIRST AID

IF ON SKIN OR CLOTHING: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. IF INHALED: Remove person to fresh air and keep comfortable for breathing. IF IN EYES: hold eve open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. IF INGESTED: call Poison Control Center or doctor immediately for treatment advice. Rinse mouth. Do not induce vomiting unless told to do so by a poison control center or doctor. Do not give anything by mouth to an unconscious person. IF EXPOSED OR CONCERNED: Get medical advice/attention if you feel unwell. Immediately call POISON CONTROL CENTER 800-222-1222.

RATE OF CONDENSE+DRA

Add 2-4 quarts of Condense+DRA per 100 gallons of spray water (0.5-1.0% v/v) when used in place of ammonium sulfate. For general use as a drift reduction agent use 1 to 3 quarts of Condense+DRA per 100 gallons of spray water (0.25-0.75% v/v). For use as a drift reduction agent for Dicamba tank mixes: Use Condense+DRA at 5 pints per 100 gallons of Dicamba spray mix (0.625% v/v). Refer to chemical label being used regarding specific adjuvant use recommendations.

Important: This product has demonstrated excellent plant safety; however, not all species and varieties have been tested. Before treating a large area, treat a small area and observe prior to full scale application.
