FIRST AID:

IF ON SKIN: TAKE OFF CONTAMINATED CLOTHING. RINSE SKIN IMMEDIATELY WITH PLENTY OF WATER FOR 15–20 MINUTES. CALL A POISON CONTROL CENTRE OR DOCTOR FOR TREATMENT ADVICE.

DISPOSAL: FOR DISPOSAL OF PLASTIC JUGS: DO NOT REUSE THIS CONTAINER FOR ANY PURPOSE. THIS IS A RECYCLABLE CONTAINER, AND IS TO BE DISPOSED OF AT A CONTAINER COLLECTION SITE. CONTACT YOUR LOCAL DISTRIBUTOR/DEALER OR MUNICIPALITY FOR THE LOCATION OF THE NEAREST COLLECTION SITE. BEFORE TAKING THE CONTAINER TO THE COLLECTION SITE:

1. TRIPLE - OR PRESSURE RINSE THE EMPTY CONTAINER. ADD THE RINSINGS TO THE SPRAY MIXTURE IN THE TANK.
2. MAKE THE EMPTY, RINSED CONTAINER UNSUITABLE FOR FURTHER USE. IF THERE IS NO CONTAINER COLLECTION SITE IN YOUR AREA, DISPOSE OF THE CONTAINER IN ACCORDANCE WITH PROVINCIAL REQUIREMENTS.
