DIRECTIONS FOR USE:

APPLICATION:

1-1.5 gallons per ton of granular fertilizer.
(Don't use on high nitrate fertilizer)

25 gallons per 1000 gallons of UAN-32 to reduce leaf burning and improve nitrogen uptake.

Always first dilute FertiCoat with the same amount of water before adding the liquid fertilizer to the FertiCoat.

When mixing with other liquid fertilizers, test for compatibility with a small quantity in a small jar.
