**GENERAL:** Finisher SS is a reacted potassium acetate with silicon dioxide. Increasing potassium and soluble silica in plant tissue has shown beneficial growth, health and production responses within plants as well as enhancing post-harvest quality.

**DIRECTIONS FOR USE:** Finisher SS may be applied foliar or to the ground using boom, air blast, or injected through irrigation systems. Always conduct a jar test to check compatibility with other products. This proprietary formulation is for use on horticulture crops, grapes, fruit trees, and berries. Seek the advice of a certified crop consultant for application rates and timings for desired crops.

**SOIL APPLICATIONS:** Apply 2-4L/Ha in a minimum of 400L of water/Ha (0.8 - 2 Qrt/acre in a minimum of 45 Ga water per acre).

**FOLIAR APPLICATIONS:** Apply 2.4-4.8L/Ha in a minimum 550L water/Ha ( 1 - 2 Qrt/acre in a minimum of 60Ga water per acre). Repeat applications as needed. To not apply more than 4 applications per season. Finisher SS must be well mixed with water before application. Conduct a jar test for tank mixing with other products.

**FIRST AID:** If on skin: Remove contaminated clothing. Wash skin thoroughly with soap and water. Wash clothing before reuse. If in eyes: Flush with running water for at least 15 minutes while holding eyelids open. Get medical attention. Ingestion: Drink 1-2 glasses of water and induce vomiting.
