## GENERAL INFORMATION

**FOLI-GRO® TIDALWAVE®** is formulated primarily for foliar or soil applications to prevent or correct zinc deficiencies in a wide range of agronomic and ornamental plants. It should be used as part of a comprehensive Total Nutrition System® for optimizing soil/nutrient conditions for plant growth, development, yield and quality.

## DIRECTIONS FOR USE

**FOLI-GRO TIDALWAVE** may be applied as a foliar spray by air or by ground, applied through irrigation such as drip or microsprinkler, or applied in-furrow. Maintain agitation to provide uniform distribution within the spray tank. Use of a high-quality Wilbur-Ellis adjuvant at recommended rates is usually advised for optimizing product performance.

Do not apply foliar sprays when plants are under excessive heat or moisture stress. Applications of foliar nutrients to leafy vegetables or soft-skinned fruit during periods of excessive temperatures may cause cosmetic injury.

### FOLIAR

**TREE NUT CROPS:** Apply 2 applications of 1-1.5 quarts per acre at pre-bloom to early bloom and full-bloom to petal fall.

**TREE FRUIT CROPS:** Apply 3 applications of 0.75-1.5 quarts per acre at pre-bloom, early bloom and post-bloom or fruit set. (Not for use in-season on bearing apples or pears.)

**GRAPES:** Apply 3 applications of 0.5-1 quarts per acre at 12-18 inch shoot growth, bloom and after fruit set. Veraison: Apply up to 3 applications starting 2 weeks prior to veraison, at 5-15% veraison, and 2 weeks later.

**CHERRIES:** Apply 3 applications of 1-1.5 quarts per acre at first white flower, at petal fall and at shuck fall.

**BLUEBERRY AND CANE BERRY CROPS:** Apply 4 applications of 0.5 quarts per acre at swollen bud, first bloom, full bloom and petal fall.

**CITRUS AND AVOCADOS:** Apply 3 applications of 1.0 quarts per acre at pre-bloom to early bloom, full bloom to 2/3 petal fall and during fall spray.

**VEGETABLE CROPS:** Apply 2-3 applications of 1-1.5 quarts per acre after transplanting or seedling emergence and every 21-30 days until maturity or fruit set.

**CORN:** Apply 1-2 pints at V4 to V8 and/or at VT-R3.

**SOYBEANS:** Apply 1-2 pints at V2-V3 and/or at R1.

**FIELD AND ROW CROPS:** Apply 1-2 pints per acre with sufficient water at vegetative stage and at or prior to reproductive stages.

**TURFGRASS:** 3-4 quarts/acre per year (0.5-1 oz/1,000 sq. ft. per month throughout the growing season and/or during times of stress).

**TREES, SHRUBS, ORNAMENTALS, NURSERY, AND GREENHOUSE:** 1-2 pints per 100 gallons of water every 2-4 weeks throughout the growing season.

## SOIL

**TREE NUT, TREE FRUIT AND CITRUS CROPS:** Apply 2 applications of 1-2 quarts per acre through drip or microsprinkler after bloom or petal fall, and 30 days after the first application.

**VINE AND BERRY CROPS:** Apply 2 applications of 1-2 quarts per acre through drip or microsprinkler beginning at pre-bloom and 21-28 days after the first application.

**VEGETABLE CROPS:** Apply 2 applications of 1-2 quarts per acre through drip or microsprinkler after transplanting or seedling emergence and 21-30 days later

**FIELD AND ROW CROPS:** Apply 0.5-1 pints per acre in-furrow with starter fertilizer or irrigation at planting.

## COMPATIBILITY

**FOLI-GRO TIDALWAVE** is compatible with many co-applied nutrients and plant protection products. Always jar test new combinations for compatibility prior to field mixing.
