### GENERAL INFORMATION

FoliMar™ Veros is a foliar-applied liquid fertilizer that is designed to provide nutrients that may be deficient in the soil or plant. Application should be made based on soil and/or plant analysis.

### DIRECTIONS FOR USE

*All rates should vary based on the severity of soil and plant tissue deficiency and degree of weather extremes.*

#### FOLIAR APPLICATIONS

FoliMar™ Veros is generally compatible with most NPK foliar nutrients and pesticides. Tank mix compatibility is impacted by water quality which may vary by location. Do NOT tank mix with Phosphate fertilizers unless agitation is available. When mixing FoliMar™ Veros with other materials, always establish compatibility using a standard quart jar method prior to mixing. Shake, stir, or swirl contents before using. Always add this product to the spray tank before adding pesticides.

AVOID foliar applications to deciduous tree crops during bloom. FoliMar™ Veros should be applied in the late evening or early morning. Do NOT spray in the heat of the day. Do NOT spray when the plant is under moisture stress. Use as fine of a spray mist as possible. Do NOT spray to the point of run off. Allow 3-4 hours after application before sprinkler irrigation to avoid washing the product off.

**For All Crops:** Apply rate of 1-4 pints per acre. Repeated applications may be required. Wait at least 10 to 14 days before reapplying.

**SHAKE WELL BEFORE USE. DO NOT STORE BELOW 40°F (5°C)**

#### COMPATIBILITY

Use in accordance with recommendations of qualified individual or institution such as, but not limited to, a certain crop advisor, agronomist, university crop extension publication, or apply according to recommendations in your approved nutrient management plan. When tank mixing other products, "Jar Test" proportionally mixed components to confirm compatibility. When blending with other products, trial blends should be conducted before beginning large scale mixing. When blending with other pesticides and fertilizers, the sequence should be as follow: water, pesticide, fertilizer, micro-nutrients.
