FIRST AID

If Swallowed: Call a POISON CENTER/doctor or Chemtrec if person feels unwell. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to by a poison control center or doctor. Do not give anything to an unconscious person.

If In Eyes: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. If eye irritation persists: Get medical advice or attention.

If On Skin: Wash affected area with plenty of soap and water. Cold water may be used. If skin irritation occurs: Get medical advice or attention.

GENERAL INFORMATION—FS AquaSupreme is a low-foaming, nonionic, activator adjuvant designed to improve the effectiveness of pesticides requiring the use of a nonionic surfactant. FS AquaSupreme enhances pesticide performance by improving spray solution coverage and penetration of target leaf surfaces.

DIRECTIONS FOR USE—The addition of adjuvants to some pesticides and/or fertilizers and their tank mixes may cause phytotoxicity to the foliage and/or fruit of desirable crops. Before using FS AquaSupreme, the applicator or crops advisor must have experience with the pesticide combination, including FS AquaSupreme, or must have conducted a phytotoxicity test.

SHAKE WELL BEFORE USING.

USE RATES

By Volume 0.125–0.5% v/v (1–4 pints of FS AquaSupreme per 100 gallons of spray solution).

MIXING

In the absence of specific mixing instructions found on the pesticide label, fill the spray tank with at least 50% of the desired finished carrier volume. When premixing in a mixing vessel or inductor, fill with at least 20% of the desired finished carrier volume. While the carrier is agitating, add tank mix ingredients in the following order:

1. Compatibility agent and/or antifoam, if needed
2. AMS, dry formulations (WP, DF, WDG, SP), and dry drift retardants
3. Dry soluble and suspension fertilizers / micronutrients
4. Liquid drift retardants and flowable formulations (F & FL)
5. Liquid concentrates, suspension and microencapsulated (LC, SC, ME)
6. Emulsifiable concentrates (E, EL or EC)
7. Solutions and soluble liquids (S or SL)
8. Liquid micronutrients and fertilizers
9. Water conditioners and other adjuvants (COC, HSOC, MSO, NIS)
10. Finish filling to desired spray volume level and continue agitation

STORAGE AND DISPOSAL

Protect product from freezing. *If product freezes, warm to room temperature before use.* Keep containers sealed when not in use. Store in original container only. Do not reuse empty container. Triple rinse (or equivalent) during mixing and loading. Recycling decontaminated containers is the best option of container disposal.
