# DIRECTIONS FOR USE READ ENTIRE LABEL BEFORE USING NOT FOR USE ON FOOD CROPS

**Gravity S 16-3-16** can be tank mixed. If you are unfamiliar with the product, a jar test should be used to confirm compatibility and a small area should be treated with the product prior to large scale application. **Gravity S 16-3-16** should not be mixed with strong acids as product degradation will occur and the fertilizer will precipitate. Apply only as directed during the growing season.

#### Caution:

- Over-application or excessive use of boron, or use on plants can result in boron toxicity and may cause serious crop injury.
- This product contains Molybdenum. Plants high in molybdenum are toxic to livestock.
- Concentration should not exceed 3 lbs of product in 1 gallon of water.
