FIRST AID

TURFGRASSES, FLOWER BEDS AND GARDENS, TREES AND SHRUBS: Apply to dry foliage and water in after application. Apply prior to or during favorable growing conditions, Brush or blow off any non-target areas to alleviate any staining or unwanted effects.

ESTABLISHED TURF: 20 lbs. / 1000 sq. ft.

THIN, WEAK TURF: 18 to 20 lbs. / 1000 sq. ft.

NEW TURF: 10 lbs. / 1000 sq. ft. prior to seeding or sodding. Rake or till into top 2 to 3 inches of soil.

FLOWER BEDS & GARDENS: 2 lbs / 100 sq. ft. Rake or till into top 2 to 3 inches of soil.

TREES & SHRUBS: Existing trees and shrubs: Apply 1 to 2 lbs. of product per inch of tree trunk diameter (maximum 20 lbs). Spread evenly over the soil out to the drip line and mix thoroughly into the soil if possible and water thoroughly.
