GENERAL INFORMATION

HARVEST MORE 5-5-45 is a complete fertilizer with both macro and micronutrients in a readily available water-soluble acidic formulation. Harvest More 5-5-45 is non-phytotoxic when used as directed.

DIRECTIONS FOR USE

It may be a violation of federal law to use this product inconsistent with its labeling.

RECOMMENDED USES

HARVEST MORE 5-5-45 can be applied foliar, and/or via drip, flood, overhead, pivot or micro irrigation systems; may also be applied in transplant water or drench, or as a side-dress. Apply the recommended amount in a volume of water sufficient to provide uniform coverage.

FOR FOLIAR APPLICATION: For all foliar applications, apply **HARVEST MORE 5-5-45** in concentration of 1 pound per 10 gallons of spray solution. Use caution if higher concentrations of **HARVEST MORE 5-5-45** are utilized as it can significantly lower pH. Best if applied when avoiding high daytime temperatures.

Field Crops: Apply 1 to 3 lbs. per acre, every 7-14 days throughout the growing season.

Vegetable, Fruit, and Nut Crops: Apply 1 to 7 lbs. per acre, every 7 to 14 days throughout the growing season.

FOR FERTIGATION: Apply 2.5 to 10 lbs per acre, every 7 to 14 days, depending on plant stage and vigor. Begin with lower rates after transplanting, or when seeded crops have emerged, and continue application as needed.

Use **HARVEST MORE 5-5-45** at the above-recommended rates on the following crops:

FIELD CROPS: Alfalfa, bean crops, canola, clover, corn, cotton, forage grasses, peanut, potato, rape (canola), rice, sorghum, soybean, sugar beet, sugarcane, sunflower, tobacco, and wheat, barley, oat, or other cereal grain.

VEGETABLE CROPS: Artichoke, asparagus, broccoli, cauliflower, cabbage, kale, and other cruciferous vegetables; leaf lettuce, head lettuce, dandelion, radicchio, arugula, and other leafy vegetables; cucumber, melon, pumpkin, squash, and other cucurbits, onion, garlic, and other bulb vegetables; tomato, pepper, eggplant and other fruiting vegetables; strawberry; carrot, sweet potato, radish, beet and other root and tuber vegetables.

FRUIT AND NUT CROPS: Apple, avocado, blueberry and other bush berries, blackberry, raspberry and other cane berries, sweet orange, lemon, mandarin and other citrus, date palm, fig, grapes, hops, oil palm, olive, persimmon, cherry, peach, plums, prune, nectarine, apricot and other stone fruit, almond, pecan, pistachio, walnut and other tree nuts, pear, pomegranate, and subtropical fruit.

MIXING INSTRUCTIONS: Follow this mixing order (1) Water (2) **HARVEST MORE 5-5-45** (3) Pesticide.

HARVEST MORE 5-5-45 will disperse in water with little agitation. **HARVEST MORE 5-5-45** is compatible with many fertilizers and pesticides. Always conduct a jar test when using new or untried combinations.
