Ensure that the herbicide is completely mixed before proceeding to the next step. SLOWLY add the HiActivate NON- IONIC LIQUID SPREADER/ACTIVATOR, agitating during the entire process. Continue to agitate while filling the tank with water and agitate before and during each application to insure a uniform spray.
