	<p>SOIL-APPLIED: IronFORCE-H3 can be applied to the root zone through drip irrigation, micro-sprinkler or side-dressing, and can easily be mixed with other chemicals or fertilizers without reacting with other materials. If using IronFORCE-H3 with liquid fertilizers, use the recommended rate (see right) of IronFORCE-H3 and add to the liquid fertilizer solution. When used with dry fertilizers, spray 2 to 8 qt / acre of IronFORCE-H3 to assure reaching root depth.</p> <p>Side Dress: Use 2 to 8 qt / acre.</p> <p>FOLIAR-APPLIED: Apply 1 to 6 pt / acre for all crops. When IronFORCE-H3 is used for foliar applications, whether by aerial or ground application, apply with enough water to thoroughly cover all foliage.
