FOLIAR APPLICATIONS: For use on **Berry crops, Tree Fruits, and Grapes:** Apply 500ml – 4L in a minimum of 120L water / Ha (1-2 qt in a minimum of 15 Gal water/acre). For use on **Oilseed, Pulse, and Cereal crops:** Apply 1.2 - 4L in a minimum of 120L of water / Ha (1.26 - 4.2 qts in a minimum of 20 gals of water / Ac). Repeat applications as needed Level Up 6% Fe should be well mixed with water before application. Conduct a jar test for tank mixing with other products.
