GENERAL INFORMATION

Liquid AMS Plus is an ammonium sulfate complex formulated with a concentrated drift reduction/deposition agent for use with a range of herbicide sprays including glyphosate.

Liquid AMS Plus prevents hard water mineral antagonism, enhances herbicide uptake while preventing herbicide crystallization on targeted surface.

Liquid AMS Plus is formulated with a high molecular weight viscosity modifier to minimize small droplets that may be susceptible to off-target drift.

The anti-evaporant ingredient in Liquid AMS Plus reduces spray loss and the antifoam ingredient suppresses troublesome foam.

NOTE

The efficacy of Liquid AMS Plus and the performance of the spray application may be affected by various environmental factors and the condition and operation of the spray equipment. Periodic calibration of spray equipment and visual inspection of the spray application may necessitate an adjustment of the adjuvant rate. When used according to the Directions For Use, Liquid AMS Plus is compatible with most pesticides and fertilizers.

DIRECTIONS FOR USE

For use with products registered for agricultural, forestry, industrial, municipal, non-cropland, ornamental, rights-of-way and other uses. This product cannot be used for aquatic applications.

The addition of Liquid AMS Plus to a tank mix should always follow the review of herbicide labels and their procedures, rates and application requirements.

Before using Liquid AMS Plus, it is recommended that the user be familiar with or conduct a field test to check for phytotoxicity of the herbicide combination.

RECOMMENDED USE RATES

Glyphosate and other tank mixes:

- Use a rate of 2.5% (2.5 gallons/100 gallons solution) for 8.5 lbs. of ammonium sulfate/100 gallons.
- Use a rate of 5% (5 gallons/100 gallons solution) for 17 lbs. of ammonium sulfate/100 gallons.

For greater deposition enhancement, use the higher range of recommended use rate for this product. Liquid AMS Plus contains 3.4 pounds ammonium sulfate per gallon.
