

## **GENERAL INFORMATION**

NUTRI-LINK® Zn 7-23-1 is a stabilized solution containing a high concentration of water soluble orthophosphate in combination with nitrogen, potassium chloride and EDTA chelated zinc.

NUTRI-LINK® Zn 7-23-1 is compatible with many liquid fertilizers and pesticides, provided that the following guidelines are followed:

- 1. Do not mix NUTRI-LINK® Zn 7-23-1 with undiluted pesticides.
- 2. Mixtures of NUTRI-LINK® Zn 7-23-1 with fertilizers based on potassium thiosulfate and/or ammonium thiosulfate should be applied directly after mixing.
- 3. Do not mix or apply with products containing calcium, magnesium, copper, manganese, zinc or iron unless they are fully EDTA chelated.
- Do not combine with antibiotics or spray oils.
- 5. Always "Jar Test" all tank mixes for compatibility before mixing for field applications.

## **GENERAL RECOMMENDATIONS**

NUTRI-LINK® Zn 7-23-1 may be applied to agricultural plants where applications of nitrogen and/or phosphorous are recommended. NUTRI-LINK® Zn 7-23-1 should be used at the rate of 2-10 Gallons per Acre – depending on plant needs. NUTRI-LINK® Zn 7-23-1 when used as directed, this product does not supply all nutrients required by plants and is to supplement a soil fertility program based on soil tests. NUTRI-LINK® Zn 7-23-1 may be applied through ground application or irrigation equipment. For ground applications equipment, NUTRI-LINK® Zn 7-23-1 may be applied alone or in combination with water and/or liquid fertilizer.

## APPLICATION AND MIXING GUIDE

APPLICATION RATES: 2 to 10 gallons per acre according to soil fertility/crop needs. Product should not be used if plant is under stress from pests, heat or inadequate soil moisture.

# USE GUIDELINES:

In-Furrow:

Canola: Apply 2 to 3 gallons per acre. Corn: Apply 3 to 5 gallons per acre.

Legumes (soya, edible, dry, alfalfa, lentils, etc): Apply 2 to 3 gallons per acre.

Potatoes: Apply 3 to 5 gallons per acre. Sunflower: Apply 2 to 3 gallons per acre. Sugarbeet: Apply 2 to 3 gallons per acre. Wheat: Apply 3 to 5 gallons per acre. 2x2/Side Dress: 2 to 10 gallons per acre.

MIXING: In any mixing operation introduce NUTRI-LINK® Zn 7-23-1 in the following sequence:

- 1. Water
- 2. NUTRI-LINK® Zn 7-23-1
- 3 Other Fertilizers
- 4. Pesticides or Soil conditioners
