GENERAL: Ocean PAK 0-7-14 is a seaweed extract fertilizer, designed to help prevent phosphate and potassium deficiencies in many different horticulture crops.

DIRECTIONS FOR USE: Ocean PAK 0-7-14 is a highly effective formulation designed for plant tissue absorption. Specific rate recommendations should be made based on the crops phosphate and potassium demand or tissue analysis. This proprietary formulation is to be applied by soil or by foliar applications on horticulture crops, vegetables, fruit trees, and small fruits.

SOIL APPLICATIONS: Apply 4-6L /Ha. Repeat up to 3 applications per season. (1.5 - 2.5 Qrt/Acr)

FOLIAR APPLICATIONS: Apply 1-1.5L/Ha (0.5 - 1 Qrt/Acr). Repeat up to 4 applications per season at 10-15 days apart during vegetative stage. Ocean PAK 0-7-14 should be well mixed with water before application. Conduct a jar test for tank mixing with other products.

FIRST AID: If on skin: Remove contaminated clothing. Wash skin thoroughly with soap and water. Wash clothing before reuse. If in eyes: Flush with running water for at least 15 minutes while holding eyelids open. Get medical attention. Ingestion: Drink 1-2 glasses of water and induce vomiting.
