PRECAUTIONARY STATEMENTS

Wear protective gloves, protective clothing, and eye and/or face protection. Avoid breathing fumes, mist, vapors or spray. Wash hands, face, and other affected areas thoroughly after handling. FIRST AID

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage, disposal or cleaning of equipment.

STORAGE: Store product locked up in original container away from pesticides, fertilizers, and food or feed, and keep container tightly closed when not in use. Do not use, spill, or store near heat or open flames. Take care to prevent water from being introduced to the contents of this container. Store at 55°F or above to maintain clear, homogeneous product. Optify[®] HSCOC is freeze/thaw stable however, if frozen, the container should be warmed to 75°F for 24 hours and shaken, mixed, or recirculated. Shake, mix, or recirculate before use.

DISPOSAL: Do not contaminate water, food, or feed by storage or disposal. Triple rinse container and pour rinsate into spray tank. Do not reuse container. Recycling decontaminated containers is the best option of container disposal. The Agricultural Container Recycling Council (ACRC) operates the national recycling program. GENERAL INFORMATION:

Optify® HSCOC is a superior blend of highly refined paraffinic crop oil and non-ionic surfactants designed for use with a broad range of pesticides where a concentrated crop oil adjuvant is recommended. The addition of this product to the spray tank utilizes the penetrating, non-evaporating properties of a paraffinic crop oil and the wetting and dispersing characteristics of a surfactant blend. When used as directed, Optify HSCOC increases the activity of herbicides by aiding in the deposition, absorption and retention of active ingredients on leaf and stem surfaces. Therefore, care must be taken in treating crops during periods when plants are subjected to drought stress, high temperatures, and high humidity. **NOT FOR AQUATIC USE IN WASHINGTON STATE.**

MIXING INSTRUCTIONS

SHAKE WELL OR RECIRCULATE BEFORE USE. (Recirculate bulk if stored below 32°F)

1. Fill sprayer 1/3 to 1/2 full of water
2. Add dry flowables or dispersible granules
3. Add emulsifiable concentrates
4. Continue to agitate until tank is 3/4 full
5. Add **Optify® HSCOC** last to the agitating spray tank

RECOMMENDED RATES

Optify® HSCOC should be applied at a rate of 4 pints per 100 gallons or 0.5% v/v in ground, aerial, low volume or CDA applications. If conventional crop oil concentrate is recommended at a rate of 1 quart per acre replace with **Optify® HSCOC** at a rate of 1 pint per acre. **Optify® HSCOC** rates are generally one half the rate of conventional crop oil concentrates.
