### GENERAL INFORMATION

PENATROL™ is a multifunctional, high load MSO adjuvant, containing a blend of 60% methylated seed oil and 40% surfactant. PENATROL is effective for surface wetting and penetration of agrochemicals through the waxy cuticle. PENATROL may be used in place of a nonionic surfactant or crop oil concentrate in a liquid spray mixture.

PENATROL may be used in place of nonionic surfactants or crop oil concentrates in liquid spray mixtures. When used as directed, PENATROL maximizes the activity of certain pesticides; therefore, care must be taken when treating sensitive crops during periods when plants are subjected to drought stress, high temperatures, and high humidity.

### **DIRECTIONS FOR USE**

Rates of PENATROL may vary with the conditions of application. Always add PENATROL last to the spray mixture while providing good agitation. Use PENATROL at a rate of 4 – 32 fluid ounces/acre as a replacement for nonionic surfactants and crop oil concentrates. The high end of the recommended use rate may be necessary during periods when plants are subjected to extreme stress or high weed populations.

**FOR PESTICIDES THAT PERMIT USE OF AN ADJUVANT AT A HIGHER RATE, FOLLOW INSTRUCTIONS ON THAT PESTICIDE LABEL. HOWEVER, DO NOT ADD THIS PRODUCT AT A RATE WHICH EXCEEDS 5% OF THE FINISHED SPRAY VOLUME. USE CAUTION AT THE HIGHER USE RATES.
