

DIRECTIONS FOR USE APPLICATION INSTRUCTIONS

- For professional use on residential and commercial landscapes, golf courses, athletic fields, parks, nurseries and sod farms.
- For best performance, apply to dry turfgrass and water after application.
- · Do not apply directly to an impervious surface or to frozen ground.
- Keep away from pools, ponds and any bodies of water. Do not contaminate potable water.
- This product contains iron, which may cause staining. Keep off unwanted areas such as sidewalks, patios, fences, and painted areas. Sweep or blow any residual material on to treated areas after application.

One 50 lb. bag will cover 3,333 sq. ft. at the recommended broadcast application rates. (13 of the 50 lb. bags per acre.)

TREES AND SHRUBS: When transplanting trees and shrubs from nursery containers up to 5 gallons in size, apply 1-2 ounces of this product in the bottom of the planting hole and 1-2 ounces around the dripline.

FLOWERS AND BEDDING PLANTS: Apply 1.5 lb. per 100 sq. ft. of landscape bed 3-4 times per growing season. Dense plant spacings may require higher fertilization rates.

RHODODENDRONS, AZALEAS, CAMERLLIAS, AND EVERGREENS: Apply 3-4 oz. around the dripline of the plant in the spring and fall.

ROSES: Apply 3-4 oz. per plant every 6 weeks during the growing season.

TURFGRASS (NEWLY SEEDED OR HYDROSEEDED): Apply 15 lb. per 1,000 sq. ft. or 60 lb. per acre at the time of seeding.

TURFGRASS (NEW SOD INSTALLATIONS): Apply 10 lb. per 1,000 sq. ft. under the sod and 10 lb. per 1,000 sq. ft. over the sod and water in.
