GENERAL: Phite Back 0-26*-27 is a potassium phosphite and humic acid blend, designed to help prevent potassium deficiencies in berry, tree fruits, and turf grass.

DIRECTIONS FOR USE: Phite Back 0-26*-27 is a highly effective potassium formulation designed for plant tissue absorption. Specific rate recommendations should be made based on the crops potassium demand or tissue analysis. This proprietary formulation is to be applied by soil or by foliar applications on vegetables, fruit trees, small fruits and turf grass.

SOIL APPLICATIONS: Apply 1-8L /Ha in a minimum 400L water/Ha. (14-112 fl oz/Acr in a minimum of 44 Gal water per Acr) Turf grass: Use 1-8L per Ha (14-112 fl oz/ Acr) (20ml - 80ml per 100 sqm)

FIRST AID: If on skin: Remove contaminated clothing. Wash skin thoroughly with soap and water. Wash clothing before reuse. If in eyes: Flush with running water for at least 15 minutes while holding eyelids open. Get medical attention. Ingestion: Drink 1-2 glasses of water and induce vomiting.
