DIRECTIONS FOR USE: Pro Cal SS is a highly effective calcium formulation designed to cover and penetrate plant tissue. Specific rate recommendations should be made based on the crops calcium demand or tissue analysis. This proprietary formulation is to be used on field vegetables, tree fruits, berry crops, and turf grass.

FOLIAR APPLICATIONS: Seek the advice of a certified crop consultant for application rates and timings for desired crops. Apply 2-5L / Ha in 450L water / Ha (**1 - 2 Qt /Acr in a minimum of 50Ga water per acr**). Repeat applications as needed. Calcium application timings are recommended during flowering and cell bulking stages. Pro Cal SS should be well mixed with water before application. Conduct a jar test for tank mixing with other products.

FIRST AID: If on skin: Remove contaminated clothing. Wash skin thoroughly with soap and water. Wash clothing before reuse.
