GENERAL INFORMATION

ProNatural® VerdeMax™ is designed for foliar applications to prevent or correct trace element deficiencies that may limit crop growth and yields. This proprietary water soluble formulation is readily available to the plant because of the natural complexing properties of amino acids. It is intended for foliar applications and is non-toxic to plants when applied as directed. This product improves nutrient uptake and utilization when included in a regular spray program.

DIRECTIONS FOR USE

SHAKE WELL BEFORE USING. KEEP FROM FREEZING.

ProNatural VerdeMax may be used on deciduous fruit, vine crops, nut crops, hops, cane berries, blueberries, legumes, grain crops, root crops, cucurbits, cole crops, leafy vegetables, woody and herbaceous ornamentals, tropical and subtropical fruit, and many other crops.

Apply with an adequate amount of water that will provide complete coverage. At a minimum, dilute one part ProNatural VerdeMax with 20 parts water. Use of a nonionic wetting agent may improve spray coverage of certain hard-to-wet plants. Do not apply undiluted.

The rate of application will depend on the crop, stage of growth, and severity of deficiency. The maximum recommended rates are for mature, full-sized plants. Reduce the rates proportionately when spraying smaller plants.

GENERAL USE: Apply 1-4 quarts per acre as needed.

APPLES: Apply 2 quarts per acre pre-bloom, 2 quarts per acre postbloom, and another 2 quarts per acre every 7-10 days as needed.

PEARS: Apply 1.5 quarts per acre pre-bloom, 1.5 quarts per acre post-bloom, and another 1.5 quarts per acre every 10 days for an additional 4 applications.

CHERRIES: Apply 2 quarts per acre as needed.

CAUTION: Not fully chelated. Avoid mixing with products containing calcium chloride.

COMPATIBILITY

Consult with your local ag representative on compatibility with other spray materials. Always jar test new combinations for compatibility prior to field mixing.
