- **LOW-CHLORIDE AND LOW-SALT** index are two primary reasons why high-value crops and crops sensitive to salts and chlorides prefer Sulfate of Potash. Lower risk of crop injury from salts or chlorides typically results in higher yields and a better quality crop.
- **VALUABLE DUAL NUTRIENT** containing 18% sulfur in the immediately plant-available sulfate form. Sulfur is required to make chlorophyll, enzymes, vitamins and other essential compounds in all crops; there can be no protein without sulfur.
- **SIZED** to blend well with most other agricultural grade nutrient sources and performs well in broadcast spreaders.

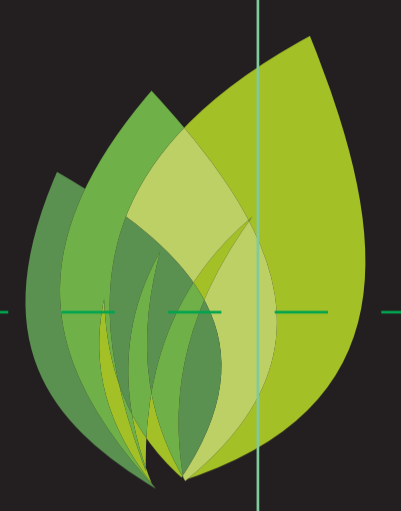
