QUENCH contains available forms of chelated divalent metals formulated to support the efficiency of nitrogen fertilization. **QUENCH** decreases the effects of excessive ammoniacal nitrogen in plants. **QUENCH** invigorates the nitrogen cycle both in the root zone and the cell supporting rhizosphere microorganisms to assist capture of more mineral nitrogen, turning them into protein. **QUENCH** is effective in strengthening the urease pathway inside the plant to get more nitrogen response out of each nitrogen unit.

RECOMMENDED USES

FOR FOLIAR SPRAY APPLICATION:

Apply **QUENCH** 8 to 16 ounces per acre every time nitrogen is applied to the following:

FIELD CROPS: Alfalfa, asparagus, bean crops, canola, clover, corn, cotton, cruciferous crops, cucurbits, melons, milo, onion/garlic, peanut, pepper, potato, rape (canola), rice, soybean, sugar beet, sugarcane, sunflower, tobacco, tomato, vegetable crops, and wheat/barley/oat.

FRUIT AND NUT CROPS: Almond, apple, apricot, avocado, banana, berry crops, cherry, citrus, coffee, fig, filbert, grapes, hazelnut, oil palm, olive, peach, pear, pecan, persimmon, pistachio, plums/prunes, pomegranate, strawberry and walnut.
