FIRST AID

GENERAL INFORMATION

RN MSO is a proprietary blend of methyl soyate and surfactant for use with insecticides, fungicides, herbicides, acaracides, defoliant, desiccants, PGR's and nutritional. The surface-active agents in RN MSO are designed to improve wetting and spreading of agricultural sprays on leaf, stem or insect surfaces. It also contains a defoamer that helps suppress spray tank foaming. RN MSO is suitable for use where the pesticide label recommends surfactants, spreader or wetter.

MIXING INSTRUCTIONS

Prior to any pesticide application all spray mixing and application equipment must be cleaned. Carefully observe all cleaning directions on the pesticide label. Fill spray tank one-half full with water and begin agitation. Add pesticides as directed by labeling or in the following sequence: 1. Dry flowables or water dispersible 2. Wettable powders 3. Flowables granules 4. Solutions 5. Emulsifiable concentrates 6. Add RN MSO last and continue agitation.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal. STORAGE: Store in original container only. Keep container tightly closed. Do not allow water to be introduced into the contents of this container. Do not store near heat or open flame. Do not store with oxidizing agents.
