GENERAL INFORMATION

SETT is a foliar or fertigation-applied nutrient solution that includes the essential nutrients calcium and boron. It can be used to correct nutritional deficiencies and/or improve crop vigor and quality with regular treatments.

DIRECTIONS FOR USE

Crop yield / plant growth may be compromised if the product is not used according to label directions.

FOR FOLIAR APPLICATION: **SETT** can be foliar applied, and through flood, drip, overhead, pivot and micro irrigation systems. Apply the recommended amount in a volume sufficient to provide uniform coverage.

RECOMMENDED USES

FOR FOLIAR APPLICATION: Apply to the plant foliage at 1 to 4 quarts every 7 to 14 days in spray volumes adequate to ensure even coverage. Reapply as needed.

FOR FERTIGATION: Apply to the root zone by flood, drip, overhead, pivot and micro irrigation systems, at 1 to 4 quarts every 7 to 14 days, as needed.

Use **SETT** at the recommended rate on the following crops:

FIELD CROPS: Alfalfa, bean crops, canola, clover, corn, cotton, forage grasses, peanut, potato, rape (canola), rice, sorghum, soybean, sugar beet, sugarcane, sunflower, tobacco, and wheat, barley, oat, or other cereal grain.

VEGETABLE CROPS: Artichoke, asparagus, broccoli, cauliflower, cabbage, kale, and other cruciferous vegetables; leaf lettuce, head lettuce, dandelion, radicchio, and other leafy vegetables; cucumber, melon, pumpkin, squash, and other cucurbits, onion, garlic, and other bulb vegetables; tomato, pepper, eggplant and other fruiting vegetables; strawberry; carrot, sweet potato, radish, beet and other root and tuber vegetables. Begin application of **SETT** 7 days after transplanting or when the crop is 3-4 inches tall, just prior to when the crop goes into a "rapid growth" stage and continue applications through fruit or storage tissue development. Applications may continue up to 7 days before the final harvest.

FRUIT AND NUT CROPS: Apple, avocado, blueberry and other bush berries, blackberry, raspberry and other cane berries, sweet orange, lemon, mandarin and other citrus, date palm, fig, grapes, hops, oil palm, olive, persimmon, cherry, peach, plums, prune, nectarine, apricot and other stone fruit, almond, pecan, pistachio, walnut and other tree nuts, pear, pomegranate, durian, papaya, passion fruit, mangos, and subtropical fruit. Begin applications pre-bloom and continue applications through harvest.

MIXING INSTRUCTIONS: Follow this mixing order (1) Water (2) **SETT** (3) Pesticide. **SETT** will disperse in water with little agitation. **SETT** is compatible with many fertilizers and pesticides; use caution when mixing with phosphorus or sulfur containing fertilizers or other chemicals known to react with calcium. Always conduct a jar test when using new or untried combinations.
