Warm Season: Bahia, Bent, Centipede, Tall Fescue, St. Augustine and Zoysia: 8.0 to 12.0 oz./1000 sq. ft. Apply 3 to 5 applications per growing season.

Cool Season: Bluegrass, perennial rye, fescue, Bent grass:

2.0 to 8.0 oz./1000 sq. ft. Apply 3 to 5 applications per growing season.

FEATURE® A.C. is specially formulated for improved compatibility with amine herbicides. It is recommended for use as an additive in dry or liquid fertilizers and is compatible with most pesticides that can be utilized in combination with liquid fertilizers. A pre-mix "jar test" is recommended prior to mixing with liquid fertilizer to check compatibility. **FEATURE A.C.** cannot be used in liquid fertilizers containing ortho-phosphates and must not be mixed with cationic pesticides.
