GENERAL INFORMATION

TETHER DRA is an all-in-one combination of water conditioning and drift reduction technology that safeguards the performance of dicamba-based products and associated tank mixes from hard water and risks associated with off target movement via particle drift. **TETHER DRA** is an approved DRA for dicamba-based herbicides and may also be used with other herbicide formulations. Check manufacturer labels and websites for confirmation.

DIRECTIONS FOR USE

The addition of adjuvants to some pesticides, fertilizers and their tank mixes may cause phytotoxicity. Before using **TETHER DRA**, the applicator or crop advisor must have experience with the pesticide combination, including **TETHER DRA**, or must have conducted a phytotoxicity test.

USE RATES

5 pints (0.625% v/v) of **TETHER DRA** per 100 gallons of spray solution with dicamba-based tank mixes.

2-3 quarts (0.5-0.75% v/v) of **TETHER DRA** per 100 gallons of spray solution with other tank mixes.

MIXING

TETHER DRA should be mixed as follows unless otherwise instructed by an accompanying pesticide label. Fill the spray tank ½ full with water, add **TETHER DRA** first, then continue filling the tank. Add remaining pesticide or nutrient products as directed on the product label (s).

STORAGE AND DISPOSAL

This product must be stored above 32°F and below 120°F. Failure to do so may cause damage.

Storage: Keep containers sealed when not in use. Store in original container only. Do not contaminate water, food or feed by storage or disposal of this product.
