GENERAL INFORMATION

TILL-IT CHARGED UP 6-0-0 is designed primarily for soil applications to prevent or correct nutrient deficiencies in a wide range of agronomic plants. Its use is suggested as a component of a regular, balanced fertilizer program to enhance yields and improve quality. Application of this product is a means of obtaining a quick response to needed elements.

TILL-IT CHARGED UP 6-0-0 should be used as part of a comprehensive Total Nutrition System® for optimizing soil/nutrient conditions for plant growth, development, yield and quality.

DIRECTIONS FOR USE

Use a maximum of 1 gallon per acre as needed in soil or water-run applications. For every 10 parts of acid, use 1 part of this product. TILL-IT CHARGED UP 6-0-0 may be applied through low volume irrigation systems and should not be used for foliar applications.

COMPATIBILITY: This product is designed to be blended with low pH fertilizers and compatibility with other products may vary. Do not combine with alkaline materials such as aqua ammonia or potassium carbonate. Do not combine with products containing calcium. Do not combine with sulfuric acid.

With sufficient agitation, TILL-IT CHARGED UP 6-0-0 will mix with ammonium polyphosphate solutions such as 10-34-0 or 11-37-0. Always jar test new combinations for compatibility prior to field mixing.
